- A. September Day of Meditation fundraiser
 - Tana will get in touch with Elizabeth Cheslak to begin preparation for marketing.
- B. Plan for fall classes
 - Not much interest in teaching right now. Amy Koch may be doing workshops. Amy Koch and Adriana Medina will connect to discuss a fall class schedule. Jason Riggs is looking to be a teacher. Lots of discussion about training, training and the future, perhaps with a certification of some sort.

- Emrich is doing well and has a few more people to register.

 In the rebuilding process we need to have a thoughtful discussion about supporting Emrich even though it succeeded, it is financially very risky. Discussion about bringing in other DSC teachers who would teach dharma along with Barbara and John Orr. Providing instruction and talks with DSC teachers, and a need to expand, Emrich can accommodate it all, this is a turning point. There is enough room at Emrich where we could have different meetings going with different teachers so people can choose their interests and if we have it at capacity there will be plenty of support for that. The planning needs to include the teachers, the ones focusing on vipassana and meditation practice. Support for Barbara is important with a retreat committee that creates the schedule and does the coordination work.
